CONSENT FOR MEDICAL TREATMENT (Minor)

As a parent of the legal guardian for the above named player, I hereby give the consent for emergency medical care prescribed by the duly licensed Doctor of Medicine or Doctor of Dentistry. This care may be given under whatever conditions are necessary to preserve the life limb or well being of my dependent.

WAIVER: I, the parent/legal guardian of the registrant, a minor, agree that the registrant and I will abide by the MYSA Rule Book, Parent Contract, and Code of Conduct of the MYSA by accepting the registrant for its soccer programs, while representing the MYSA in parade participation and activities (the "Programs") and FIFA Laws of the Game, I hereby release, discharge and/or otherwise indemnify the MYSA, its affiliated organizations and sponsors, their employees and associated personnel, participating including the owners of the field and facilities utilized for the Programs, against any claim by or on behalf of the registrant's participation in the Programs and/or being transported to and from the same, which transportation I hereby authorize.

PARENT CONTRACT

ZERO TOLERANCE POLICY: All players, parents, coaches, and spectators are expected to demonstrate good sportsmanship behavior before, during and after games, scrimmages, and practices. The Club has adopted a "Zero Tolerance Policy" towards verbal or physical abuse or harassment by anyone involved in the club in any capacity. Any parent or spectator who is ejected from the game by the referee will remove him or herself from the sidelines and area immediately. If the parent or spectator does not remove him or herself from the sidelines and area immediately, then the coach of that child's parent or spectator will be given five (5) minutes to ask that parent or spectator to leave the premises or that team will be forced to take a forfeit. He or she will be banned from attending the next scheduled game and can be banned for longer if so determined by an inquiry of the Monticello Youth Soccer Association Board of Directors.

PARENT'S PLEDGE: As a parent of the Monticello Youth Soccer Association player, I pledge to support my player, their teammates, and their coach's efforts at all times. Respect the opponent players, coaches, fans, and game officials at all times. Cheer encouragements to my player and teammates, but NOT instructions. Get my player(s) to practices, training sessions, and games on time and prepared. On time means on the field and not in the car getting shin guards on, prepared means with water, and appropriate attire. Appropriate attire means no jewelry unless medically necessary and that all players must be wearing shinguards with socks pulled up over the shinguards at all times in practices and at games. Discuss all issues with my child privately and at a time away from the game, teammates, and spectators. Inform coaches in advance of any practices, training sessions, games that you know your child will need to miss or arrive late to. Avoid any confrontation with game officials, coaches, or opposing team parents and will refrain from any unsportsmanlike and poor parenting behavior including verbal or physical abuse of players, coaches, game officials, and spectators at practices, before, during, and after games.

CODE OF CONDUCT

Any person (player, parent, coach, referee, board member, volunteer, or any other individual) acting on behalf of or associated with the Monticello Youth Soccer Association (MYSA) is expected to conduct themselves appropriately and abide by this Code of Conduct. All MYSA members have a responsibility to act and speak appropriately when representing our association. At all MYSA sponsored activities, in and out of the State of Arkansas, the following code of conduct is in effect: 1. MYSA members will refrain from participating in or encouraging any of the following: Assault, Harassment, Racial or Religious Violence, Sexual Violence or Harassment, Taunting or Showboating, Vandalism, Drug, Alcohol, and/or Tobacco use, Gambling, Inappropriate language and/or actions, Providing false information, Harassment of other club officials, referees, coaches, and/or players 2. MYSA members will be an example of good sportsmanship to all players, coaches and parents, and address all players in a positive, encouraging manner. 3. MYSA members will respect and support all coaches, players and officials through words and actions. 4. MYSA members will view opponents as necessary friends that provide players the opportunity to participate. 5. MYSA members will abide by all established policies and decisions of the MYSA board of directors. Steps that will be taken if a violation has occurred: First Offense- a meeting must take place with the MYSA of Directors. Participation in all MYSA activities will cease until this meeting has occurred. Punishment will be determined after this meeting has occurred. Second Offense- the person in violation will be suspended from any MYSA involvement for a period of time to be determined by the MYSA Board of Directors. Any future return to MYSA involvement is not guaranteed but may be granted, depending on the nature and severity of the infraction. Involvement will then be granted on a probationary basis. Any violation during that probation period will result in permanent suspension from the MYSA. If an offense is severe in nature (extreme, violent and/or dangerous) the MYSA reserves the right to move directly to the consequences of the second offense, after which a meeting may take place.
